MISSION

Veterans Court strives to connect veterans involved in the criminal justice system to services and support while promoting sobriety, recovery, and stability. With a focus on resource coordination and guided rehabilitation. Veterans Court offers a chance for justice-involved veterans to conquer problems and get their lives back on track. Veterans Court also provides the community with an opportunity to give back to the individuals who have served, and who often suffer from the devastating physical, psychological, and emotional wounds of war.

GOALS OF VETERANS COURT

- Help veterans through recovery during and after their interaction with the criminal justice system
- Reduce the use of jail and repeated interaction with the criminal justice system
- Improve public safety
- Improve the likelihood of success with treatment, access to housing, and linkages with other supports

OVERVIEW

Allegheny County Veterans
Court is a treatment court
designed to serve justice
involved veterans who may be
struggling with behavioral
health, substance abuse,
reintegration, or other issues,
including the often unseen
wounds of war. Since its
inception in 2009, Allegheny
County Veterans Court has
provided services to a growing
number of veterans.

VETERANS COURT PARTNERS

Veterans Court is a team approach in which partners to the Court—Office of the District Attorney, Public Defender's Office/ Duquesne University School of Law Veterans Clinic, Adult Probation, Allegheny County Jail-Veterans Pod, VA-Veterans Justice Outreach, Justice Related Services, Veterans Leadership Program/Peer mentor program, and the Vet Center—work together to collectively support veterans and their individual needs while participating in the court.

ELIGIBILITY REQUIREMENTS

- Individuals must either have qualifying past military service for which they were not dishonorably discharged or be a current military member in good standing.
- Veterans must have qualifying charges, and either treatment needs (mental health, drug and alcohol, reintegration, etc.), or a military or combat deployment.
- The District Attorney's Office must consent to case admission and vet the cases for victim and/or police officer consent.

Cases considered for admission to Veterans Court include a wide range of both misdemeanor and felony cases where the Veterans Court team believes admission will assist the veteran as well as improve community safety.

REFERRAL PROCESS

All Veterans Court referrals must be submitted in writing by completing a referral form. The form may be obtained in person at the Allegheny County Courthouse, Room 534, or by email from the contacts below, who can also answer referral questions:

VETERANS COURT REQUIREMENTS

Veterans Court requirements include but are not limited to:

- Attend regular review hearings before the court
- Complete the court ordered service plan

Court participants are assigned to a Veteran Justice Outreach Specialist or a Justice Related Services Specialist, who connect and refer the veteran to treatment providers and services, and who facilitate the veteran's compliance with his/her service plan. Veterans are also assisted with housing, health, financial benefits, and other appropriate community support services. Veterans Court also provides participating veterans with the opportunity to benefit from the assistance, support, guidance, and encouragement of a fellow veteran peer mentor.

GRADUATION

Veterans Court participants may become eligible for graduation and termination of supervision if fully compliant with the court and after successfully completing at least half of their Veterans Court sentence. Completion of Veterans Court is determined on a case-by-case basis.







